Conditions of Participation

These conditions of participation are valid for "Die Stunde von Wien" as well as the "Sunset Run" within the VCM Lauf-Sommer.

- 1.) You adhere to the regulations of the Austrian Ministry of Health valid at the respective event and the rules of conduct regarding Covid-19 (page 3 "Covid-19 Rules").
- 2.) Die Stunde von Wien and the Sunset Run are sporting events. You are not allowed to participate in the run if you are sick or injured. We reserve the right to disqualify you for giving false information during registration, shortcutting the course, obstructing other participants, changing the official race number, current or past suspension by a sports federation or anti-doping agency. Participation on bicycles, inline skates, scooters, skateboards and similar is not allowed. For safety reasons, escorts on such means of transport are also not allowed.
- 3.) Your registration and payment will be done via the registration platform njuko SAS, which is used by us for the participant registration. A late registration on site is not possible.
- 4.) You will receive a race number, which is used for timing and must be worn during the race. In times of Covid-19 it is essential that we as organizers know exactly who our participants are.
- 5.) Before, during and after the run, please be sure to follow the instructions of the organizing team as well as the emergency personnel.
- 6.) You agree that we as organizers do not assume any liability for theft, accidents, injuries, infections caused by pathogens or damages, unless there is gross negligence or intent on our part.
- 7.) We organize the run basically in all weather conditions, but in coordination with the authorities we reserve the right to cancel the run in case of danger or in case of changed legal regulations, to change it in the planned form or to cancel it.
- 8.) If the event has to be cancelled, we will refund the entry fee. Should you not be able to participate in the event for whatever reason, you will not be entitled to a refund.
- 11.) We want to be as flexible as possible and react well to possible new requirements. Organizational changes can therefore be made at short notice.

Since we have no contractual relationship with these persons, we also have no influence on the use of these photos.

Covid-19 Regeln

- On July 1, the Austrian government announced the repeal of most Covid rules. However, a regulation is not yet available. In any case, behave considerately so that we all experience an atmospheric running event without crowds and congestion.
- Follow the instructions of our staff on site and pay attention to the info announcements of the moderator.

We will actively inform participants about further measures that we as organizers may implement in accordance with legal requirements and for reasons of prevention.
