



Conditions of participation

The following conditions apply to your participation in the VCM Virtual Race 2021.

1. You will responsibly abide by the Covid-19 rules that apply at the location of your race.
2. You adhere to the legal requirements on your running route, e.g. road traffic regulations.
3. Only start if you are healthy and run in such a way that you stay healthy.
4. Participation is only possible by running or walking. Means of transport such as bicycles, inline skates, scooters, ... are not allowed.
5. You record your activity yourself with the VCM app.
6. You perform your sporting activity and upload your personal result without technical manipulation.
7. Recordings from the track in a stadium cannot be accepted, as in this case the GPS measurement accuracy could be distorted more than usual.
8. The results list has no official character due to the different conditions of track, weather and measuring accuracy of the respective devices.
9. We reserve the right to disqualify you due to false registration information, manipulation of your results, current or past suspension by a sports federation or an anti-doping agency.
10. Your registration is only possible online in the given time slot on the corresponding registration platform against payment of the entry fee.
11. Uploading your results is only possible in the given time slot on the corresponding platform.
12. You undertake your run on your own responsibility you agree that we as organisers do not accept any liability for theft, accidents, injuries, infections caused by pathogens or damage.
13. If the event has to be cancelled, we will refund the entry fee. Should you not be able to participate in the event for whatever reason, you will not be entitled to a refund.
14. For participants over 14 years of age, the parents or their legal guardians agree to these conditions of participation.
15. We want to be as flexible as possible and react well to possible new requirements. Organisational changes can therefore also be made at short notice.

The registration takes place via the registration portal of Njuko, which saves the data entered by you in accordance with the DSGVO. This also applies to the bank or credit card data required for payment processing and the payment service provider commissioned by Njuko for the processing. Your e-mail address does not appear publicly anywhere. We will send you information about organisational, security and event-related news and services in connection with the VCM Virtual Race to this address.
2. Your participant data will be linked to a start number and forwarded to mika:timing GmbH for GPS tracking in the VCM App. mika:timing GmbH operates the App on our behalf and is responsible for the tracking and presentation of results.
3. The results are passed on by Enterprise Sport Promotion GmbH for the publication of results on www.vienna-marathon.com to JKU Linz, which manages this site.
